This is a summary of the annual report for the FOOD EMPLOYERS AND TEAMSTERS LOCAL 463 RETIREMENT SAVINGS PLAN, (Employer Identification No. 23-7418948, Plan No. 001) for the period January 1, 2019 to December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$1,802,744. These expenses included \$55,053 in administrative expenses and \$1,747,691 in benefits paid to participants and beneficiaries. A total of 667 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$22,585,005 as of December 31, 2019 compared to \$19,994,097 as of January 1, 2019. During the plan year the plan experienced an increase in its net assets of \$2,590,908. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$4,393,652, including employer contributions of \$855,668, employee contributions of \$51,133 and employee rollover contributions of \$176,525 earnings from investments of \$3,300,571 and other income of \$9,755.
